# VIII. Project Updates

#### A. E Site

- 1. Results of PERC Test The Tioga County Department of Health finalized the PERC; based on their evaluation, alternative onsite wastewater treatment systems (OWTS) will be needed; will continue to look at alternative possibilities such as municipal sewer; water individual septic and wells; discussion will continue.
- 2. E Site STREDC Loan Approval in the amount of \$800,000 STREDC recommends funding for the \$800,000 loan with the following terms:
  - \$800,000 at 1% for 20 years. Interest only payments would be allowed for up to 10 years, unless parcels are sold or leased before the 10th anniversary. Upon sale of any part of the property, all of the purchase price will be paid as repayment for the loan principal (or if the purchase price exceeds the sums outstanding on the loan, the borrower will pay to STREDC such lesser amount of the purchase price as may be required to pay off all sums outstanding on the loan).
  - STREDC shall take a 1st mortgage on the real estate.
  - Current property insurance shall be maintained on the real estate in amount sufficient to cover the total outstanding debt; with STREDC designated as mortgagee.
  - All applicable local, state and federal requirements to apply.

The request will go to regional counsel for final approval and a commitment letter will be sent out.

- 3. ESD Grant Award The ESD has awarded an estimated amount of up to \$50,000 to include site development for the initial phase of the project which includes a 20,000 SF and a 5,000 SF building with associated parking and utilities. The key components of the design are expected to also include site grading, storm water pollution prevention plan, water and sewer, and site access. There is a 50/50 match for this grant award; partners for the match are \$20,000 from the IDA, \$20,000 from the County and \$10,000 from the Tourism office. The IDA is waiting to hear from ESD with the formal incentive proposal.
- B. Update on the construction at the Army Reserve Training Center construction of the Army Reserve Training Center is about 40% completed; after the project is finished there will be six (6) full time regular employees at the facility 4 administrative and 2 maintenance positions; those attending the facility will be 100 175 Army Reserve recruits for three weekends out of the month.
