NEW BUSINESS

Local Law No. 3 of 2022 – Local Law No. 3 of 2022; a Local Law repealing Local Law No. 1 of the Year 2022 and imposing additional surcharges for telephonic communication pursuant to the authority of Tax Law §186-g and County Law §337 is slated for adoption at the March 15, 2022 Legislature meeting following due diligence of a public hearing on February 24, 2022. The collection start date for this new local law is June 1, 2022 and the 45-day required notification will be sent to all known carriers following the March 15, 2022 Legislature meeting.
