REPUBLICAN PARTY

RESOLVED: That the Morning Times is hereby designated as the newspaper published in the County of Tioga for the Republican Party to publish the Election notices issued by the Secretary of State, and to publish the official canvass pursuant to County Law $\delta 214$, Subd. 1.

RESOLUTION NO. –19 DESIGNATION OF NEWSPAPER FOR

DEMOCRATIC PARTY

RESOLVED: That the Tioga County Courier is hereby designated as the newspaper published in the County of Tioga for the Democratic Party to publish the Election notices issued by the Secretary of State, and to publish the official canvass pursuant to County Law δ 214, Subd. 1.

RESOLUTION NO. –19 SET SALARY OF CHAIR

RESOLUTION NO. -19 APPOINT COUNTY AUDITOR

AND DEPUTY COUNTY AUDITOR

WHEREAS: The County is required to appoint a County Auditor and Deputy County Auditor to process and review the Purchase Orders submitted by County Departments for payment of a variety of bills; and

WHEREAS: The terms for these appointments coincide with Legislator Group One and are due for reappointment as of January 1, 2019; therefore be it

RESOLVED: That Maureen L. Dougherty, be and hereby is appointed County Auditor for a three (3) year term, commencing January 2, 2019 and ending December 31, 2021; and be it further

RESOLVED: That Cathy Haskell be and hereby is appointed Deputy Tioga County Auditor, to act in the absence of the County Auditor, said term to be the same as that of the County Auditor.
