NEW BUSINESS

GSA Per-Diem Rate Discussion - Ms. Haskell reported she wanted to discuss the current policy related to per-diem meal reimbursement allowances prior to the Chief Accountant issuing the 2023 General Services Administration (GSA) per-diem rates. Ms. Haskell researched the historical trend of how the County has established these rates noting the following methodology; flat daily rate, GSA established rates, and currently since 2011 using GSA established rates less 30%. Ms. Haskell reported staff is beginning to resume travel and she is receiving feedback that the current GSA chart using the less 30% rates are not adequate for some travel locations. In addition, the 2022 GSA chart provides a link for out-of-state travel, however, this is contradictory to current practice of the County using the standard rate less 30% for areas not listed on the chart for a total daily rate of \$41.00.

The Legislators decided to set a standard daily rate of \$65.00 for all travel within New York State and an out-of-state GSA rate based on the specific travel location via https://www.gsa.gov/travel/plan-book/per-diem-rates/per-diem-rates-lookup/,

in accordance with the time of travel and the meal reimbursement allowances breakdown rates per meal.

ACTION: Ms. Haskell will prepare a resolution for Legislature consideration at the January 10, 2023 Legislature meeting to amend the Employee Handbook Travel Policy and Procedures and the Purchasing and Payment Policy to reflect the standard daily perdiem rate of \$65.00 for all travel within New York State, in accordance with the time of travel and the Meal Reimbursement Allowances Breakdown Rates of \$14.00 for breakfast, \$16.00 for lunch, \$30.00 for dinner, and \$5.00 for incidentals. Out-of-state travel will be based on the provided GSA link, in accordance with the time of travel and the established Meal & Incidental Rates. Ms. Haskell will request the Chief Accountant establish a 2023 Meal Reimbursement Allowances Chart based on the newly adopted policies for distribution to the Departments following the January 10th Legislature meeting.

Local Law Introductory No. A of 2023 – Ms. Haskell reported due to the timing of the 2023 election cycle process and the need to establish the salaries for the County Clerk and Sheriff prior to petition carrying the first week in March, Ms. Haskell asked Personnel Officer Parke to attend today's meeting to provide salary recommendations for these two offices. Ms. Parke provided salary recommendations for both offices based on using the historical methodology from the former Personnel Officer. Ms. Haskell reminded Legislators these are recommendations, and that the Legislature can propose their own recommendations.

2022 Annual Report Legislative Clerk/County Auditor

2022 - A NOTABLE YEAR

2022 was a bittersweet year for the Tioga County Legislature.

We started out the year welcoming three new Legislators: District #1 – Ron Ciotoli; District #3 – Barbara Roberts; and District #4 – William Jake Brown. All three Legislators were sworn in at the First Special and Organizational Meeting of 2022 on January 3, 2022.

Sadly, the Legislature mourned the loss of current Legislator Eddie J. Hollenbeck and former Legislator Frank John "Bud" Waite.

- o **Frank John "Bud" Waite** passed away on October 21, 2022. Mr. Waite served 16 years on the Legislature from January 1, 1986 December 31, 2002. The County posthumously recognized Mr. Waite at the November 15, 2022 Legislature meeting with his wife, children, and grandchildren receiving the resolution.
- o **Eddie J. Hollenbeck** passed away on November 23, 2022 while currently serving his 12th year as District #7 Legislator. Legislator Hollenbeck was appointed to the position on August 10, 2011, to fill the unexpired term of Legislator William Oberbeck and was successfully re-elected every term thereafter. Legislator Hollenbeck was appointed Deputy Chair on April 11, 2017; a position he was appointed every year thereafter. Legislator Hollenbeck will be most notably remembered for his leadership, steady even-keeled demeanor, willingness to serve wherever needed, and being a great man his fellow Legislators, staff and community respected. A moment of silence was held at the December 13, 2022 Legislature meeting.

The Legislature also mourned the loss of one former and one current employee in 2022.

- o **Ken Del Bianco, former Commissioner of Public Works**, passed away on Christmas Day 2021 and a moment of silence was held at the January 11, 2022 Legislature meeting. Mr. Del Bianco was an employee of Tioga County for 14 years and retired on March 23, 2015.
- o **Jay Wilber, Assistant Public Defender**, passed away while in service on October 14, 2022 and a moment of silence was held at the November 15, 2022 Legislature meeting. Mr. Wilber was an employee of Tioga County since February 12, 2020.

- o **Bethany O'Rourke, Personnel Officer**, retired on March 18, 2022 with 24 years of service. The Legislature appointed Linda Parke on June 6, 2022 as the new Personnel Officer to fill the unexpired term through March 20, 2028.
- o **Terie Huseby, Real Property Director**, retired on April 15, 2022 with 8.5 years of service. The Legislature appointed Steven Palinosky as Acting Real Property Director on April 18, 2022 and appointed him as Director of Real Property on November 16, 2022 to fill the unexpired six-year term through September 30, 2025.

LEGISLATIVE MEETINGS - CONDUCTING THE BUSINESS OF THE COUNTY

The Legislature convened 12 regular meetings, 10 special meetings, and 10 public hearings. Minutes scribed, typed, indexed, and copied for the official Journal of Proceedings.

The Legislature adopted 420 resolutions, including 12 Recognition Resolutions honoring the dedicated service of long-term employees retiring with 20 - 34 years of County employment.

The Legislature adopted several policy revisions, including reference change from Non-Union to Management/Confidential, as part of the County's Employee Handbook: Rules of the Legislature, Social Media Use, Assignment & Use of County Vehicles, Tioga County Fund Balance, Comprehensive Information Security, County Hours of Operation, and Purchasing & Payment Policy. Two new policies were adopted: Records Management Policy and Rights of Nursing Employees to Express Breast Milk.

The Legislature acknowledged 27 proclamations in 2022. Most notably were **Employee Recognition**, **Military Caregiver Month**, **Hunting Safety Month**, **Human Trafficking Awareness Month and Stress Management & Seasonal Affective Disorder**.

The Chair of the Legislature gave the State of the County Address at the Fourth Regular Legislature Meeting on April 12, 2022.

COUNTY AUDITOR/BUDGET OFFICER

The County Auditor and Deputy Auditor reviewed and processed \$450,879.68 in purchaser card transactions.

The County Auditor and Deputy Auditor reviewed and processed 8,614 accounts payable invoices equating over \$22.5 million dollars.

The Budget Officer presented the 2023 Tentative Budget at a Public Hearing on November 15, 2022. The 2023 County Budget was adopted at the Twelfth Regular Legislature Meeting on December 13, 2022.

TRAININGS

The Legislative Clerk conducted an Administrative 101 Training on January 19, 2022 with 100% participation from all Departments. Topics included: Open Meetings Law, resolutions, proclamations, agendas, and minutes. Reference guide was developed.

The Legislative Clerk completed the task of implementing a Munis Training Development Team for the purpose of scheduling and conducting in-house trainings.

STATE MANDATED PLANS

On May 18, 2022, Governor Hochul signed **Executive Order 18 - Preventing and Responding to Domestic Terrorism.** This Executive Order mandated every county to develop and maintain a Domestic Terrorism Plan for submission on or before December 31, 2022. The County's Office of Emergency Services developed and submitted the required plan on time.

The **Countywide Shared Services Initiative** started in 2017 and Tioga County has participated and complied every year since. The Shared Services Panel developed and submitted a Plan to New York State Department of Budget on December 20, 2021 with an effective date of January 1, 2022. The 2022 Plan includes two projects from Tioga County and the Owego-Apalachin Central School District both relating to health insurance/prescription drug management.

- Local Law No. 3 of the Year 2022 A Local Law repealing Local Law No. 1 of the Year 2022 and imposing additional surcharges for telephonic communication pursuant to the authority of Tax Law §186-g and County Law §337 was adopted on March 15, 2022.
- Local Law No. 4 of the Year 2022 Repeal of Local Law No. 5 of the Year 2006 and the enactment of a replacement law providing for the administration and enforcement of the New York State Uniform Fire Prevention and Building Code was adopted on December 13, 2022.
