APPROVAL OF MINUTES: Motion to approve January 7th, 2025, committee meeting minutes. Motion made by Legislator Ciotoli, seconded by Legislator Monell; motion carries unanimously.

FINANCIAL:

- Reviewed Real Property budget YTD and January revenue/expense.

OLD BUSINESS:

- Senior exemption scale updates:
 - Dryden School District has raised the base of their senior exemption scale from \$19,500 to \$29,000. This affects 28 parcels in the Town of Richford. It does apply to the 2025 assessment roll.
 - Village of Waverly is planning to raise the base of their senior exemption scale from \$9,000 to \$14,300. If passed, this change will apply beginning with the 2026 assessment roll.

NEW BUSINESS:

- Elderwood Nursing Home Tax Certiorari:
 - Tax certiorari filed in July 2023 to reduce the assessed value of two parcels, one by 75.6% and the other by 63.6.
 - o Town of Barton and Elderwood have been in mediation, final agreement is pending.
 - Barton Town Attorney to brief the Town Board and public February 10th at 6:30 PM, County Director to attend.
 - o Impacts
 - Refunds from School, Village, and Town & County taxes from roll vears 2023 and 2024.
 - Reduction in total assessed value least for County (less than .2%), most for Village (over 3%).

- Image Mate public facing platform for finding information on individual parcels:
 - Contract for the platform has been with SDG. They have been bought out by Schneider Geospatial.
 - Short term we will continue with Schneider who will migrate data from SDG platform to Schneider platform.
 - Long term will evaluate Schneider platform and receive demos from other companies.
- School Districts:
 - Noted some issues with Owego-Apalachin CSD School tax payment processing, working with District and Treasurer to resolve, correction of errors both received and pending.
 - Issues have been identified regarding boundaries between Maine-Endwell CSD and Newark Valley CSD. RP will be researching and seeking clarification.
