Tenth Regular Meeting October 12, 2021

The Tenth Regular Meeting of 2021 was held on October 12, 2021 and was called to order by the Chair at 12:00 P.M. All nine Legislative members were present.

Chair Sauerbrey turned the meeting over to Legislator Roberts who incorporated a moment of silence as today's prayer in memory of Sr. Investigator, Clifford Alexander, who passed away on September 25, 2021.

Legislator Roberts spoke. "As Chair Sauerbrey mentioned, I would like to ask for a moment of silence for Clifford Alexander, Sr. Investigator, Sheriff's Office."

Legislator Roberts led all Legislators and those in attendance in the Pledge of Allegiance.

There were 21 people in attendance.

Chair Sauerbrey reported we have two Proclamations that will be read and presented; Employee Recognition & Appreciation Week and Green Light for Military Service County and one Proclamation; Dental Hygiene Month that will be noted in the minutes.

Legislator Balliet read and presented the Green Light for Military Service County proclamation to Veterans Service Agency Director Michael Middaugh.

COUNTY OF TIOGA EXECUTIVE PROCLAMATION

WHEREAS: Approximately 200,000 service members transition from military to civilian communities annually and there is an anticipated 20% increase in that transition due to the drawdown of the Afghanistan/Iraq War; and

WHEREAS: Current studies indicate that 44-72% of service members experience high levels of stress during the transition period from military to civilian, sadly for these transitioning members they are at the highest risk for suicide during their first year after military service; and

WHEREAS: The Tioga County Legislature appreciates the sacrifices that our United States military personnel have made while defending freedom and believe that specific recognition should be accorded them in appreciation for their service; and

WHEREAS: Designating this as a time to salute and honor our men and women in uniform who are making the transition to civilian life by switching one lightbulb to green to show visible support for these veterans; therefore

The TIOGA COUNTY LEGISLATURE, County of Tioga, does hereby proclaim October 13, 2021 through Veterans Day, November 11, 2021 as a:

GREEN LIGHT FOR MILITARY SERVICE COUNTY

and in observance of Operation Green Light for Military Services encourages its citizens to recognize the importance of honoring all those who made immeasurable sacrifices in preserving freedom by displaying a green light in a window of their residence and/or business. Green is the color of hope, renewal, and wellbeing, and that by this simple act of changing one light to green, we can spark meaningful conversation regarding the recognition of veterans and help "green light" them forward as valued members of our communities.

Veterans Service Agency Director Michael Middaugh spoke. "Thank you to the members of the Legislature and Chairwoman Sauerbrey. Recently, Chairwoman Sauerbrey was elected President of New York State Association of Counties (NYSAC), which was a great honor for our little county. As a result of this, and as a member of the New York State County Veterans Service Officers Association, we are partnering with them on Operation Green Light across the State of New York. We became the first county to make the official proclamation regarding that and we are highly promoting it. We are trying to get businesses involved throughout the County within the next month. It is not just something we want to do for a month, but we want to do throughout the year. Our little agency has been picked as a pilot program for the National ETS (End of Terminal Service) sponsorship program. National ETS is the leave within a year of a veteran's separation and will now be mentored through our agency if they are returning to this area of New York, so that they can find housing, employment, and adapt to coming back from military service into the civilian community. Hopefully, we will lower those suicide rates of 22 a day, which is the whole purpose behind Operation Green Light.

"The New York State County Veterans Service Officers Association asked and appointed me to be the national representative to the National County Veterans Service Officers Association to bring New York's issues to the national level and to help with legislative changes at the national level for more funding for veterans and local services across the country. I will be representing the State over the next year as the new national representative".

AGREEMENT WITH OPIOID SUPPLY CHAIN PARTICIPANTS CONCERNING CLAIMS RELATED

TO THE OPIOID CRISIS

WHEREAS: Tioga County has joined in a legal action seeking compensation from those who are responsible for causing and perpetuating the opioid addiction crisis (the "Action"); and

WHEREAS: The Action is against several defendants, including manufacturers of opioids, distributors of opioids and chain pharmacies; and

WHEREAS: The Action alleges several causes of action against defendants McKesson Corporation, Cardinal Health, Inc. and AmerisourceBergen Corporation together with subdivisions PSS World Medical, Inc., Kinray, LLC, Bellco Drug Corporation and American Medical Distributors (Collectively "Settling Distributors") based on claims that these entities contributed to the opioid epidemic by failing to comply with their obligations under the federal Controlled Substances Act and the New York Controlled Substances Act to implement adequate measures to prevent diversion of the prescription opioids they distributed to pharmacies and others, all of which contributed to a public health crisis in New York; and

WHEREAS: These "Settling Distributors" have offered to settle the claims against them over eighteen (18) years and agreeing to implement injunctive relief under a controlled substance monitoring program; and

WHEREAS: The final amount to be received by Tioga County will have a potential value of between \$805,683.12 and \$1,423,227.69 depending upon overall participation and milestones; and

WHEREAS: It is in the best interest of Tioga County to resolve this matter with respect to these Settling Distributors without further litigation and enter into an agreement to settle all allegations against the Settling Distributors and avoid protracted litigation; therefore be it

RESOLVED: That Tioga County is authorized to settle its claims with the above named Settling Distributors and Tioga County Chair of the Legislature Martha Sauerbrey is authorized to execute such forms and agreements, as approved by

the County Attorney, to compromise the claim of these Settling Distributors and distribute the proceeds between the participating Plaintiffs.
