  - Porshea spearheaded the event and was the main speaker
  - Kylie shared 200 bags given out
  - 10 Agencies represented
  - Vigil Walk

- Save A Life Day – 9/26/24
  - Will hold Narcan trainings

- Will be at the Spencer Food Cupboard, in the morning
- Red Door in Waverly in the afternoon
- Tioga Downs in the evening
- Coalition Evaluator meeting held
  - Using REACH (website) for data
  - Scheduling a time for the evaluator to do a site visit
    - Probably at the end of this year or early spring
- DFC Year 6 – STOP ACT Year 1 ending in September
  - Working on budgets
    - Advertising, billboards, salary & fringe
    - A lot of money has not been spent
  - Hoping to do a full budget modification
  - Steering committee will meet at the end of the year
- CADCA
  - Unclear if anyone will be sent
  - May find other trainings
  - 4-day CADCA Boot Camp may be mor feasible
- Drug Take Back scheduled for 9/26/24
  - To be held at the HHS Building
  - Will have sharps disposal
  - Possibly doing a half day at the Waverly Police station
- STAP working with the Red Door
  - Harm reduction vending machine there
- Porshea is still working with the homeless encampment in Owego
  - They are still at the same site for now
